No. GG/80/MTS/102014/925/V : In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951(Bom. XXII of 1951) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Motor Vehicle Fitter (Grade I), Class III, in the subordinate service of Motor Transport Organization of the Police Department, namely :-

1. These rules may be called the Motor Vehicle Fitter (Grade I), Class III, in the Motor Transport organization of the Police Department Recruitment, Rules, 2016.

2. Appointment to the post of Motor Vehicle Fitter (Grade I), Class III, in the subordinate service of the Motor Transport Organization of the Police Department shall be made either -

(a) by promotion of a person of proved merit and efficiency from amongst the persons, who,-

(i) have worked for not less than five years in the cadre of Motor Vehicle Fitter (Grade II), Class III, or Motor Vehicle Greaser (Grade II), Class III, in the subordinate Service of Motor Transport Organization of the Police Department;

(ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub - clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two - thirds of the period specified in sub clause (i) above; or

(b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-

(i) not be less than 18 years of age and not be more than 33 years of age :

Provided that the upper age limit may be relaxed in favor of a candidate belonging to the Scheduled Castes, Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Section or women or who is already in the service of Government of Gujarat in accordance with the provisions of the Gujarat Civil Service Classification and Recruitment (General) Rules, 1967;

(ii) possess a Diploma in Automobiles Engineering or Mechanical Engineering obtained from the Technical Examination Board (TEB) or any of the Universities established or incorporated by or under the

Central or a State Act in India or any other educational institution recognized as such or declared to be deemed as a university under section 3 of the University Grants Commission Act, 1956, [3 of 1956;]

- (iii) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- (iv) possess the minimum requisite standard of physique as specified in Appendix A appended to these rules;
- (v) possess valid motor driving license of Heavy Motor Vehicle within stipulated period of service on contractual basis;
- (vi) possess adequate knowledge of Gujarati or Hindi or both.

4. The provision of rule 9 A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.

5. The candidate appointed by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.

6. The candidate appointed by direct selection shall require to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by Government.

Minimum Physical Standards for the Post of Motor Vehicle Fitter (Grade I), Class III; (Motor Transport Organization) in the Police Department.

Norms to be taken in to consideration by the Medical officer.

Physical Standards

A. All Male candidates [should be physically fit as per standards for different classes of persons as specified below.]

* Minimum expansion of chest when Inflated shall not be less than 5 centimeters.

B. All Female candidates [should be physically fit as per standards for different classes of persons as specified below.]

C. Candidates who have got any one or more of the following physical defects shall be considered physically unfit:

knock knee, Pigeon Chest, Squint Eye, Flat Feet, Varicose Veins, Hammer Toes, Fractured Limb, Decayed Teeth, Communicable/Skin Disease.
