No. **GG-9/2011/JLM/502007/3120/J**:- In exercise of the powers conferred by the proviso to Subsection (10) of Section 59 and Section 6 of Prisons Act, 1894 and in supersession of all the existing rules issued in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of *Hawaldar (Male) Class-III in the Subordinate Service of the Inspector General of Prisons*, namely :-

1. These rules may be called the *Hawaldar (Male) Class-III, in the Subordinate Service of the Inspector General of Prisons Recruitment Rules, 2011.*
2. Appointment to the post of *Hawaldar (Male), Class-III in the subordinate service of the Inspector General of Prisons shall be made either:-*
  - (a) by promotion of a person of proved merit and efficiency – from amongst the persons who:
    - (i) have worked for not less than five years in the Cadre of Sepoy, Class-III; and
    - (ii) have passed the qualifying examination for Computer Knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules 2006,

Provided that where the appointing authority is satisfied that a person having the experience specified in clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in clause (i) above;

or

- (b) by direct selection;

3. To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall -
- (a) not be less than 18 Years of age and not be more than 25 years of age;
  - (b) (i) have passed Higher Secondary School Certificate Examination Conducted by Secondary and / or Higher Secondary Education Board or possess an equivalent qualification recognized by the Government.
  - (ii) have fulfilled the requisite criteria of physical standards as prescribed in Appendix "A" annexed to this rules:
  - (iii) possess the basic Knowledge of Computer Application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967,
  - (iv) have passed the initial physical test namely, cycling, jumping etc, held in this behalf at the time of recruitment and also to pass a course of physical training
  - (v) possess a valid light or heavy motor vehicle driving license of about two years as on the date of application.
  - (c) possess adequate knowledge of Gujarati and/ or Hindi  
Provided that preference may be given to candidate who
    - (i) possesses 'C' certificate examination of National Cadet Corps, or
    - (ii) have worked for about three years in Home Guards or Civil Defense and also completed its refresher course and basic training or
    - (iii) have secured first, second or third rank in athletics or yoga competition or any sport recognized by state Government or
    - (iv) have participated in recognized State level or National Level sports


Provided that such preference shall not exceed ten percent of the total posts advertised for recruitment.

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Class or who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

4. A candidate appointed by direct selection will be kept on probation for a period of one year.

5. A candidate appointed by direct selection shall, during his probation period, be required to undergo Prison training and to pass the Prison Training Examination in accordance with the Rules as may be prescribed by the Government.
6. The candidate appointed by direct selection shall during his probation period be required to pass the qualifying examination for Computer Knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules 2006.
7. A selected candidate will be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
8. A candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Government.
9. A selected candidate will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.



**Minimum Physical Standards for the post of Hawaldar (Male) Class - III**

Norms to be taken in to consideration by Medical Officer

1. These rules may be called the Hawaldar (Male) Class III, in the subordinate service of the Inspector General of Prisons Recruitment (Amendment) Rules, 2014.
2. In the Hawaldar (Male) Class III, in the subordinate service of the Inspector General of Prisons, Recruitment Rules, 2011. (hereinafter referred to as "the said rules"), in rule 3, in clause (a), for the figures and word "25 years", the figures and word "28 years" shall be substituted.
