**No.GG/99/2019/MTS/102010/806/V:** - In exercise of the powers conferred by clause (b) of section 5 of the Gujarat Police Act, 1951 (Bom.XXII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Police Sub-Inspector (Motor Transport) Class III, in the subordinate service of the Police Department, Recruitment Rules, 2015, namely: -

1. These rules may be called the Police Sub-Inspector (Motor Transport) Class III, in the subordinate service of the Police Department, Recruitment (Amendment) Rules, 2019.
2. In the Police Sub-Inspector (Motor Transport) Class III, in the subordinate service of the Police Department, Recruitment Rules, 2015, In rule 4, in clause (a),
  - (i) for the figures and word "30 years", the figures and word "35 years", shall be substituted;
  - (ii) after the existing proviso, the following proviso shall be inserted namely:-

"Provided further that the upper age limit may also be relaxed in favor of a candidate belonging to the Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections and in favor of Women Candidate in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;"
