Prisons No. GG/51/2009/JLK/172009/474/ J :- In exercise of the powers conferred by Section Act, 1894 59 read with section 31 of the Prisons Act, 1894 (IX of 1894) in its application to the State of Gujarat, the Government of Gujarat hereby makes the following rules further to amend the Gujarat Prisons (Diet for Prisons) Rules, 1975, namely :-

- (1) These Rules may be called the Gujarat Prisons.
(Diet for Prisoners) (Amendment) Rules 2009.
- (2) In the Gujarat Prisons (Diet for Prisoners) Rules, 1975, after rule 2, following rule shall be inserted, namely :-

" 2A - Certain Prisoners not to be permitted any article of food from private sources:-

Notwithstanding anything contained in these rules, the criminal prisoners including unconvicted prisoners and detunes of the categories specified hereunder shall not be allowed or permitted to receive, consume or possess any articles of food, cold or hot drink, juice or any home made food items from private sources, other than those prepared and cooked in the Jail Premises.

Categories

- (a) The prisoners who are notorious, dangerous and involved in gang wars or inter state crime or offences having international ramification,
- (b) The prisoners who are involved in the offences falling under section 392 to 402 of the Indian Penal Code,
- (c) The prisoners upon whom the restrictions have been imposed under section 268 (1) of the Criminal Procedure Code, 1973,
- (d) the prisoners who are involved in the serious offences under the Arms Act, 1959, the Conservations of Foreign Exchange and Prevention of Smuggling Activities Act, 1974, the Explosive Act, 1884, the Explosive Substances Act, 1908, under the Narcotics Drugs and Psychotropic Substances Act, 1988, or under the Unlawful Activities (Prevention) Act, 2008.
- (e) The prisoners who are kept in the high security yard,
- (f) The prisoners who are involved in activities of spying or escaping from Jail,

(g) The prisoners who are dangerous to Jail discipline and security,

(h) The prisoners involved in terrorist activities,

(i) The prisoners belonging to banned organization."
