There are certain posts of the rank of District Superintendent of Police in the Police Department which are not included in the I.P.S. cadre Schedule of the State. These posts being Ex-cadre (or non-cadre) posts with reference to the I.P.S. cadre of the State, are not posts in the line of promotion of the State Police Service Officers. The State Government are not empowered to create cadre posts in the I.P.S. cadre. However, in the interest of public service, ex-cadre posts of the rank of District Superintendent of Police are created by the State Government. There is no ban on appointment of non-cadre officers on ex-cadre posts in the I.P.S. (Cadre) Rules, 1954.

2. Whenever such ex-cadre posts are

required to be filled up by non-cadre officers of Dy. Superintendent of Police's rank, a panel of suitable officers for appointment to such posts should be available. For this purpose, it is necessary to institutionalise the process of selection from the State Police Service officers of Deputy Superintendent of Police rank fit for appointment as S.P./D.S.P./Commandant on the ex-cadre posts of District Superintendent of Police rank by constituting a committee.

-: R E S O L U T I O N : -

In supersession of Government Resolution, Home Department No. DYS.1083/4590/3, dated 3.4.84, Government is pleased to constitute a Committee of the following officers to prepare a panel of the State Police Officers of Dy. S.P. rank fit for appointment on the ex-cadre post of D.S.P. rank:-

1) Secretary, Home Department

Convenor.

2) Secretary (Par.), G.S.D.

Member.

3) Dir. Gen. of Police
& I.T.P., G.S. Ahmedabad.

2. The Committee shall consider the names of State Police Service Officers in the rank of

Deputy Superintendent of Police in the order of their seniority and prepare a panel, applying the criterion of proved merit and efficiency. The Committee shall prepare a panel as and when necessary as per requirement of State Police Service Officers for appointment as S.P./D.S.P./Commandant of the rank of D.S.P. on the ex-cadre posts.

3. The existing pay-scale of the ex-cadre post of District Superintendent of Police is of Rs. 1100-1600. Service on one ex-cadre post does not count for the purpose of increment on another ex-cadre post in the event of transfer. The pay drawn on any ex-cadre post does not count for pension/gratuity.

4. The inclusion/non-inclusion in the panel will have no effect whatsoever, for the purpose of consideration of a SPS officer for inclusion in the select list for appointment to I.P.S.

5. The panel prepared by the Committee for making appointment on Ex-cadre posts shall not be operated for making appointment on any I.P.S. cadre post.

6. The sealed cover procedure laid down under Government Resolution, General Administration Department NO. S.L.T.1080/895/G.2 of 23.9.81 need

"3. The existing pay-scale of the ex-cadre post of
District Superintendent of Police is of Rs. 3000-4500. The
services rendered on the ex-cadre post shall be counted for
the purpose of increment in the case of subsequent
appointments on the ex-cadre post (S) A State Police service
officer retiring from Ex-cadre post will be entitled to get
the pensionary benefits of pay drawn in the payscale of
the ex-cadre post."
