**Gujarat  
Prohibition

No. GG/77/2019/VDR/10/2006/2996/E-1:- In exercise of the powers conferred by sub-section (2) of section 6 of the Gujarat Prohibition Act, 1949 (Bom. XXV of 1949) and all other powers enabling it in this behalf, the Government of Gujarat hereby amends the Government Notification, Education and Labour Department No : GH/SH/197/BPA-1070/19560(I)-P, dated the 1<sup>st</sup> April, 1975, as under :-
